

This Memorandum of understanding (MoU) is coming force on 15TH Oct 2018 by and between **ONE STOP CENTRE-SAKHI, BERHAMPUR, ODISHA (SOCS)**, set up under the Ministry of Women and Child Development, Govt.of India to support women in distress, currently located atMKCG Medical College Campus, Berhampur, Ganjam, Pin- 760004, here in represented by its Centre Administrator **Ms. Mahasweta Padhyand Science College, Konkorada(SCK)**, an institutionimparting education to the undergraduate students affiliated to Berhampur University, located at Konkorada, Ganjam, Odisha, herein represented by its Principal, **Dr.PrafulaRouta**.

In order to advance and enrich their mutual objectives by way of providing emergency and non-emergency access to a range of services to women in distress, including legal and psychological counselling, promoting for all of them, as also enabling and advancing their curricular requirement of providing free legal aid and undertaking joint initiatives for protection and sensitization of rights of women in distress.

I. OBJECTIVES

Article 1: To provide women in distress emergency and non-emergency access to a range of services including legal and psychological counselling.

Article 2: To facilitate the distressed women by our degree students including curricular and outreach activities of joint venture.

Article 3: To associate for the purpose of organizing sensitization programmes regarding rights of vulnerable groups, particularly women and children, in educational and other institutions, at the request of either of the parties to this MoU.

Article 4: To collaborate for the purpose of providing students who are enrolled at SCK for the purpose of assisting the authorities of the SOSC.

II. GENERAL PROVISIONS

Article 5: SCK shall provide students in batches of 3 to 4 students per batch, to the SOSC for the purpose of providing assistance for procedural requirements like recording of evidence and related legal matters.

Article6: In case of sensitization programmes, SCK shall have the responsibility for mobilizing resources and the conduct of the different programmes.

Article 7: Ordinarily, the expenses relating to the obligations under this agreement will be born by the party proposing the programmes and neither party shall claim contrary to this understandingunless sharing of such expenditure has been agreed upon in writing between the parties.

Article 8: Any dispute or difference arising between the parties shall be settled by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolutions.

Article 9: Nothing in this Memorandum of Understanding is intended to affect the cooperation or collaboration between the parties.

Article 10: This MoU is based on the professional competence and expertise of each of the parties hereto and therefore, neither party shall transfer or assign rights or obligations arising out of this agreement, either wholly or in part to any third party.

III. AMENDMENTS

Article 11: No amendment or modifications of the MoU shall be valid unless the same is made in writing by both the parties and specifically stating that the same is to be considered as an amendment to the MoU. The modifications shall become part of the MoU and shall be effective on the date of which they are executed unless otherwise agreed upon and shall terminate with the termination of this agreement.

Article 15: A Report for the activity is to be documented by SOSC and SCK, which shall be vetted by the signatories to this MoU before such report is published in any form whatsoever.

Article 16: This MoU has been executed in two original copies, one of which has been retained by SOSC and the other by SCK.
